Remarks:

- 1. Fine determinations are divided into 10 degrees according to accumulated points of each individual illegal occurrence, and are proclaimed with maximum and minimum amounts correspondingly.
- 2. Punishment according to Article of:
 - "R43R" means the case(s) of radio enterprise(s) punished by Article 43 of the Radio and Television Act;
 - "R43T" means the case(s) of television enterprise(s) punished by Article 43 of the Radio and Television Act;
 - "R44IR" means the case(s) of radio enterprise(s) punished by Paragraph 1 Article 44 of the Radio and Television Act;
 - "R44IT" means the case(s) of television enterprise(s) punished by Paragraph 1 Article 44 of the Radio and Television Act;
 - "R44IIR" means the case(s) of radio enterprise(s) punished by Paragraph 2 Article 44 of the Radio and

Television Act;

- "R44IIT" means the case(s) of television enterprise(s) punished by Paragraph 2 Article 44 of the Radio and Television Act;
- "R45-1" means the case(s) of the illegally installer of stations, relay stations, or other broadcast systems punished by Article 45-1 of the Radio and Television Act;
- "R49" means the case(s) of responsible person or staff members of radio/television enterprise(s) or program supply enterprise(s) that violated the Radio and Television Act or the regulations made according the same Act and punished by Article 49 of same act;
- "CR65" means the case (s) of cable radio/television system operators (cable television broadcasting system) punished by Article 65 of the Cable Radio and Television Act; and
- "SR36" means the case(s) of satellite broadcasting enterprise(s) punished by Article 36 of the Satellite Broadcasting Act.
- 3. The fine in this table is calculated in NT\$, and the unit is "ten thousand dollars (NT\$10,000)".
- 4. Case(s) punished by other laws (such as Article 63 of the Children and Youth Welfare Act, Article 13 of the Sexual Assault Crime Prevention Act and so on) shall be divided into 10 degrees based on the maximum and minimum limits of the fine, and the fine shall be determined by the degree of accumulated points.
