Note :

1. The attached copies must be stamped with the company size stamp, organizational seal or signature (signature) according to the applicant.
2. Those that have been installed abroad and have completed the inspection, or the ship radio walkie-talkie has passed the inspection, shall be exempt from applying for installation approval.
3. The copy of the verification report of the yacht for self-use must be within three months of the completion date of the inspection.
4. Only ship radio walkie-talkies or hand-held two-way UHF radio telephone stations with an output power of less than ten watts may be exempt from inspection and renewal.
5. The self-inspection checklist for the renewal of the ship radio station is only applicable to ships sailing outside of international routes and not ocean-going fishing vessels; those who change radio equipment are not applicable.
